- Printing and distributing posters and leaflets for forest fire protection (over 40,000 posters and leaflets each year)















LAW OF FIRE PROTECTION

(Published in the "Official Gazzete of Republic of Macedonia" no. 67 from October 4, 2004 yr.)

Article 22


- (1) In order to participate in extinguishing fires and rescuing people and property, volunteer fire protection societies can form volunteer fire units.
- (2) The units referred to in paragraph (1) of this Article should have at least ten operational firefighters.
- (3) The voluntary fire units, for extinguishing fires have fire-fighting equipment, facilities for fire fighting and personal protective equipment.
- (4) Firefighters of voluntary fire units have uniform and symbols on the uniform.
- (5) Fire Protection Union of Macedonia, after earlier opinion issued by the Directorate, with a separate act sets out the types and minimum amounts of fire-fighting equipment for volunteer fire units, their personal protective equipment, as well the type and appearance of the uniform and uniform markings.

Article 23

- (1) Operational firefighter in volunteering fire brigade can be a person who:
- Is aged between 18 and 65 years (men) or to 55 years (women)
- Is healthy and psychophysical capable for accomplishment fire suppression works
- Has completed a course for volunteer firefighter.
- (2) The course for volunteer firefighter is conducted by the Fire Protection Union of Macedonia.
- (3) The program for implementation of the course for volunteer firefighter brings the Fire Protection Union of Macedonia, after earlier opinion issued by the Directorate.

Article 7

- (1) For the purpose of extinguishing fires in forests and other open spaces, in terms of increased risk of occurrence of such fires, at the request of the Directorate for Protection and Rescue, municipalities engage seasonal firefighters. Priority in engagement of seasonal firefighters have the firefighters from the volunteer units and societies who served at least two years.
- (2) Prior to the engagement, firefighters in paragraph (1) of this Article shall be obliged to perform training under a special program that brings Directorate.
- (4) The cost of engaged seasonal firefighters will be covered by the municipality of which are engaged.



Conclusions/Experiences

- 1. The volunteerism must be regulated by Law and be part of the system for fire protection.
- 2. The volunteerism can be a solution in regions where there is a lack of professional personnel.
- 3. The volunteers must be in full cooperation and coordination with the official institutions and organizations (the fire service and forestry in particular). *They must not act on their own hand!*
- 4. The volunteerism cover all aspects of the fire protection (prevention and suppression) and include all categories of citizens (in terms of age, gender, religion, profession, etc.).
